Tiffany Leijten - Aging and Veterans Services - Caregiver Retreat coming up on March 23, 2023 and planning meetings are ongoing.

Gina Innes - IHSS - Career pathways incentivizes caregivers for IHSS through training and there is an opening in the IHSS advisory committee.

Elba Scherer - Hands on Central/Americorps - Working to get connected with Veteran Services in Stanislaus County.

Maria Profeta - HICAP - Medicare open enrollment happening and HICAP forums coming up for older adults. Part B Medicare premium and deductible is going down. Medicare enrollees who are kidney transplant recipients and receive medications will have the opportunity to continue on Part B Medicare who are less than 65 years old.

Hayley Vieyra - MOVE - Transportation for vaccine clinic on October 19th, PASS program allows older adults to get bus tickets for those 55+.
